

The Tennesseans deserve better health and better health care system. Politically, judicially, and socially.

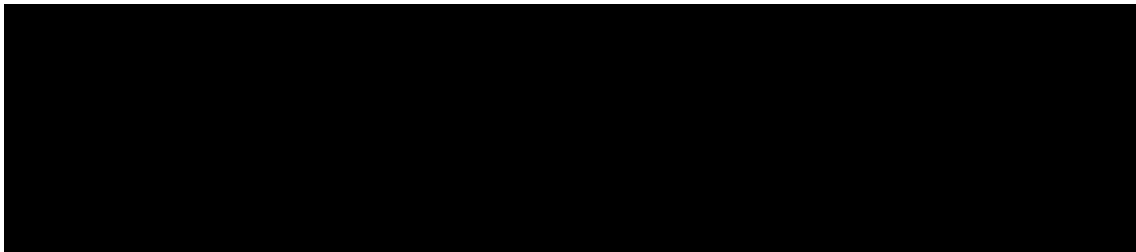
